

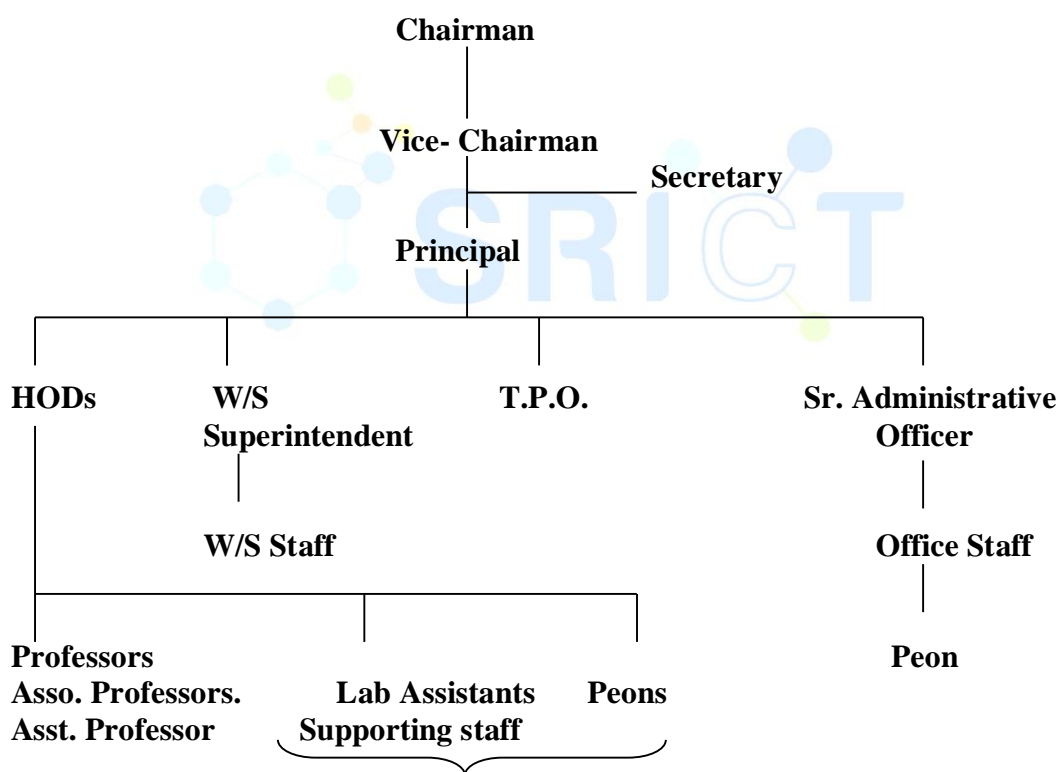

Circular

The Fee Regulatory Committee which is constituted under the **Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007** by exercising power conferred upon it under section 10 of the said Act has determined the fee structures of unaided professional institutions imparting professional education and which are falling within its purview for the block period of 3 years of 2017-18, 2018-19 and 2019-20 as per the Appendix attached herewith. The fee determined by the committee is applicable to a student who is admitted in that academic year and shall continue to apply till completion of his or her course in the same institution. The difference between the provisional fee charged by the institution and the fee determined by the committee shall have to be paid by the student if the fee determined is higher than the provisional fee charged by the institution and paid by the student **OR** the institution will have to refund the difference to the student if the provisional fee charged by it, is higher than the fee determined by the committee. The institution shall not charge or collect any fee other than the fee determined by the committee. It is also not allowed to collect the fee at a time amounting to more than one term fee from a student in an academic year.

ANNEXURE-F

Guidelines for Tuition Fee Waiver (TFW) Scheme

1. The Tuition Fee Waiver Scheme shall be applicable to all the sanctioned seats of the engineering and pharmacy courses in the Government colleges or institutions , grant-in-aided colleges or institutions and unaided colleges or institutions approved by AICTE, New Delhi;
2. The supernumerary seats not exceeding five percent of sanctioned intake of the colleges or institutions shall be filled on the basis of merit of the candidate, the annual income of whose parents is less than Rs. 2.5 lakhs from all sources of income;
3. The Tuition Fee Waiver Scheme shall be for the complete duration of the course and the students admitted under this scheme shall not be allowed to change the institution or the course under any circumstances.

Important Note:

To get the benefit of TFW scheme, the candidate has to submit the income certificate issued after 31st March 2011 from either 'Mamlatdar' or 'Taluka development officer' or Collector (Jan Seva Kendra) at the time of registration for admission. No other certificate/document will be considered valid (e.g. Income tax return copy, Certificate issued by 'Sarpanch' of Grampanchayat etc.)

10. The institution shall operate only from the approved location, and that the institution shall not open any off campus study centers / extension centers directly or in collaboration with any other institution / university / organization for the purpose of imparting technical education without obtaining prior approval from the AICTE. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.
11. The tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students / guardians of students in any form. If found so, appropriate action as per the notified regulations shall be initiated against the Institution.

15. It shall be mandatory for the technical institution to maintain a Website providing the prescribed information. The Website information must be continuously updated as and when changes take place.
16. If a technical Institution fails to disclose the information or suppress and / or misrepresent the information, appropriate action as per the notified regulations shall be initiated against the Institution.
17. AICTE may carry out random inspections round the year for verifying the status of the Institutions to ensure maintenance of norms and standards.




