

Circular

The Fee Regulatory Committee which is constituted under the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 by exercising power conferred upon it under section 10 of the said Act has determined the fee structures of unaided professional institutions imparting professional education and which are falling within its purview for the block period of 3 years of 2017-18, 2018-19 and 2019-20 as per the Appendix attached herewith. The fee determined by the committee is applicable to a student who is admitted in that academic year and shall continue to apply till completion of his or her course in the same institution. The difference between the provisional fee charged by the institution and the fee determined by the committee shall have to be paid by the student if the fee determined is higher than the provisional fee charged by the institution and paid by the student **OR** the institution will have to refund the difference to the student if the provisional fee charged by it, is higher than the fee determined by the committee. The institution shall not charge or collect any fee other than the fee determined by the committee. It is also not allowed to collect the fee at a time amounting to more than one term fee from a student in an academic year.
