#### Details of report:

Ms. Upasana Prajapati (student of 7<sup>th</sup> Sem., Chemical Engineering, Admission Batch 2013 SRICT) has registered a complaint against Mr. Mandar Mehta (student of 2<sup>nd</sup> semester Chemical Engineering, Admission Batch 2015, SRICT) dated 22-10-16.
