1. SRICT SCHOLARSHIP SCHEMES FOR BE (FIRST YEAR)

1.1 SCHOLARSHIP SCHEME FOR SC & ST STUDENTS:

Program: B.E. (Mechanical Engineering, Electrical Engineering, Chemical Technology and Environmental Science & Technology)

- Family Income : Less than 2.5 lakh per annum
- No of Students : All eligible students as per ACPC
- Eligibility : HSC pass out and registered student with ACPC
- Tuition fee : 100 % waive off
- Hostel fee & Food charges : 100 % waive off
- Reimbursement to student: Rs.5000 per semester for taking care about his/her basic needs like stationery, local transportation and uniform etc.
- Process for selection of students : SRICT management will scrutinize individual application based on personal interview, merit, economic conditions of family etc. and permit students for this scholarship

1.2 SCHOLARSHIP SCHEME FOR SEBC & OPEN (NARMADA AND BHARUCH)

Program: B.E. (Mechanical Engineering, Electrical Engineering, Chemical Technology and Environmental Science & Technology)

- No of Students : 40 students on First cum First basis (EE-10, ME-10, CT-10, EST-10)
- Area : Bharuch and Narmada District
- Family Income : Less than 2.5 lakh per annum
- Eligibility : HSC pass out and registered student with ACPC
- Tuition fee : 100 % waived off
- Hostel fee : 100 % waived off for outside of Bharuch District
- Transportation : 100 % waived off for local student

- Food charges : Paid by Student
- Process for selection of students : SRICT management will scrutinize individual application based on personal interview, merit, economic conditions of family etc. and permit students for this scholarship

1.3 SCHOLARSHIP SCHEME FOR MERITORIOUS STUDENT (GUJARAT)

(Program: B.E. (Mechanical Engineering, Electrical Engineering, Chemical Technology and Environmental Science & Technology)

- Eligibility (Entry level): HSC with more than 80 percentile and registered student with ACPC, Gujarat
- Family Income : Less than 8 Lakh per annum
- Scholarship Amount : 50 % of Tuition Fee or Rs.50,000.00 whichever is less
- Documents: Domicile certificate of Govt. of Gujarat, Income Certificate of Father, of every year, Aadhar Card, Degree Certificate, Mark sheets of HSC and mark sheet of previous semester for continuation of scheme
- Eligibility (Continuation of scheme): Attendance more than 75 % and Passed out semester exams (from semester 1 to 8) with 6.5 SPI without backlog in respective semester
- Explanation : Under this scheme SRICT college will provide scholarship up to 50 % of tuition fee (Maximum up to Rs.50,000) to the student who will secure more than 80 % percentile in HSC and Clear their semester exams(Sem-1 to Sem-8) with 6.5 SPI and without backlog in respective semester.
- Process for selection of students: SRICT management will scrutinize individual application based on personal interview, merit, economic conditions of family etc. and permit students for this scholarship.

2. MUKHYAMANTRI YUVA SWAVLAMBAN YOJNA BY GOVT OF GUJARAT

Student who has secured more than 80 percentile in HSC examination and his/her family income less than Rs.6 Lakh per annum, he /she will eligible for this scholarship .Government of Gujarat will pay up 50 % of his/ her station fee or up to Rs.50,000.00 whichever is less. SRICT college will help eligible student for get benefits from Government of Gujarat .

3. FREE SHIP CARD BY GOVT OF GUJARAT

Student who is belong to SC category and his/her family income would be less than 2.50 lakh is eligible for this scheme. Free Ship Card is issued by Director , Scheduled Caste Welfare

EDUCATIONAL LOAN SCHEMES OF INDIAN BANKS ASSOCIATION:

Purpose:

Payment of course fees. Purchase of books, equipment, instruments, uniform, payment of hostel fees, examination fees, study tours for studies in India

Eligible Courses Professional courses:

Engineering, Medical, Agriculture, Veterinary, Law, Dental, Computer, Management, etc.

Processing fee: No processing / upfront charges may be levied on loans sanctioned under the scheme.

Repayment: Commences two years after completion of the course or six months after getting employment, whichever is earlier.

Loan with interest is repayable in equated monthly instalments within:

- For loans Upto Rs.7.5 lacs 10 years after commencement of repayment
- For loans above Rs.7.5 Lakhs up to 15 years after commencement of repayment
- No prepayment penalty

Credit Delivery

Loan can be availed from the branch nearest to the place of permanent residence of the parent / guardian. Ostentation of UID number (Aadhaar) of the student is compulsory

Rate of interest

- Interest to be charged at rates linked to the Base rate as decided by individual banks
- Simple interest to be charged during the study period and up to commencement of repayment.

Eligibility:

- Should be an Indian National with no specific restriction for age of the student.
- Should have secured admission on merit to professional/technical courses in India including management quota.

A candidate who has passed the qualifying examination after appearing in the supplementary examination conducted by the Board shall be eligible for admission in the current academic year on the vacant seats declared under rule 19.
